- Regular reporting to the funder and other key stakeholders.

- Build capacity on Redcap use
- Build capacity and provide supportive supervision for SCCC M&E staff on data collection and management, reporting processes, systematic use of defined tools and M&E.
- Develop training curricula and provide training for M&E staff
- Develop tools that support data use within programs.
- Build capacity of the programme teams to use data in a strategic manner to inform programme decision making.
- Report regularly to senior management on data collection and quality, adherence to standards and timelines, and on reports, processes and systems.
